In connection with conduct of JNVST-2018 for admission to Class-VI, representations are being received stating that a few more JNVST applications which were submitted timely by the parents are still with DEO/BEO in offline form. The earlier process was through DEO/BEO only and hence there is a possibility of some forms may have been submitted to them till 04th December 2017 or before.

If no data is received from your office by 22nd January 2018, it will be presumed that no application was with District Administration. **Please ensure that the data pertaining to additional candidates only are to be forwarded to this office.** Please do not forward the details which were already forwarded to this office. Principals may be advised to contact DEO and BEOs again to confirm the availability of timely submitted JNVST applications, if any. This will be the last opportunity provided in this regard. On any account, no further request to add any candidate for JNVST shall be entertained by this office. Further, you are requested to direct all the Principals to notify this on their website and notice board.
